**DECLARING MUNICIPAL ORDINANCE NO. 97-140415
OF THE SANGGUNIANG BAYAN OF VILLASIS,
PANGASINAN, ENTITLED "OTHERWISE KNOWN AS
THE HEALTH AND SANITATION CODE OF THE
MUNICIPALITY OF VILLASIS, PANGASINAN" AS
WITHIN THE CONFERRED POWERS OF THE
SANGGUNIANG BAYAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 97-140415 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16, 17 (a) (2) (iii) and (vi) and 447 (a) (1) (iii) and (vi), (4) (i) and (ii) and (5) (xiii) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements set forth in Sections 59 and 511 of RA 7160;


