**APPROVING RESOLUTION NO. 239, S-2016-19 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY OF URDANETA FOR CY 2017 IN THE AMOUNT OF TWENTY-FIVE MILLION SIX HUNDRED SIXTY-TWO THOUSAND AND SIXTY-THREE PESOS (P25,662,063.00)"**

**WHEREAS**, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 239, S-2016-19 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Urdaneta City, Pangasinan has formulated the city's Supplemental Annual Investment Program (AIP) No. 2, CY 2017 amounting to P25,662,063.00. This was endorsed through CDC Resolution No. 3-A-2017 dated September 18, 2017 to the Sangguniang Panlungsod and was subsequently approved by their Sangguniang Panlungsod thru Resolution No. 239, S-2016-19 dated September 26, 2017;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
