**RESOLUTION NO. 23-2024**

**DECLARING ORDINANCE NO. 190, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE GRANTING OF INCENTIVES TO COLLEGE STUDENTS GRADUATING CUM LAUDE, MAGNA CUM LAUDE OR SUMMA CUM LAUDE IN ANY PUBLIC OR PRIVATE SCHOOL INSTITUTION AND APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 190, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (5) and (xi) of R. A. No. 7160; 1987 Philippine Constitution; Republic Act No. 109311, otherwise known as "Universal Access to Quality Tertiary Education Act"; Republic Act No. 10648 entitled: "An Act Providing Scholarship Grants to Top Graduates of All Public High Schools in State Universities and Colleges and Appropriating Funds Therefor;

**WHEREAS**, the Municipality of Basista, Pangasinan shall include in its Annual Investment Plan the Program on the Granting of Incentives to College Students Graduating Cum Laude, Magna Cum Laude or Summa Cum Laude;




