This AGREEMENT made this 25<sup>th</sup> day of January 2024 between the **PROVINCIAL GOVERNMENT OF PANGASINAN**, of the Philippines (hereinafter called the "Procuring Entity") of the one part and **DCS TRADING** (hereinafter called the "Contractor/Supplier") of the other part;

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted.  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation.
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by the existing laws and/or the Procuring Entity concerned in the PBD's. **Winning bidder agrees that the additional contract documents or information prescribed by the contract execution, such as the Notice to Proceed, Variation Orders, and warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Twelve Million, Three Hundred Seventy-Seven Thousand, Four Hundred Fifty Pesos Only (P12,377,450.00)** or such other sums as may be ascertained, **DCS TRADING** agrees to the **Supply and Delivery of Fertilizers at Provincial Agriculture Office Lingayen, Pangasinan (to be used by the Farmers in Identified Tobacco Growing Municipalities of the Province of Pangasinan); Excise Tax; PR No. 2023-12-7826; Solicitation No. PANG-2023-12-1586-G**, in accordance with his/her/its Bid.
4. The **PROVINCIAL GOVERNMENT OF PANGASINAN** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.





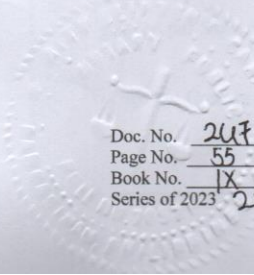
