PROVINCIAL RESOLUTION NO. 5-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH POSITIF CORPORATION FOR THE PROVISION OF MEDICAL/DENTAL SERVICES AND FACILITIES BY THE POZORRUBIO COMMUNITY HOSPITAL

WHEREAS, the 1987 Constitution ensures the protection and promotion of the right of the people to health and guarantees the availability of essential health services to all the people at affordable cost through various plans and programs;

WHEREAS, the Pozorrubio Community Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 5th District of Pangasinan;

WHEREAS, Positif Corporation is a duly registered private construction company with main office located in Las Piñas City that is operating a Construction Yard at Barangay Labayug, Sison, Pangasinan;

WHEREAS, Positif Corporation has signified its intention to avail of the services and facilities of the Pozorrubio Community Hospital;

WHEREAS, the Pozorrubio Community Hospital will serve as an affiliate hospital of Positif Corporation for its personnel and employees' medical/dental services and facilities upon written endorsement of the latter;

WHEREAS, the terms and conditions for the provision of medical/dental services and facilities are already defined in the Memorandum of Agreement;




