PROVINCIAL RESOLUTION NO. 8-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE MUNICIPALITY OF BAYAMBANG, PANGASINAN AND THE PHILIPPINE MEDICAL SOCIETY OF NORTHERN CALIFORNIA (PMSNC) FOR THE CONDUCT OF A JOINT 5-DAY SURGICAL, MEDICAL AND PEDIATRIC MISSION IN THE PROVINCE

WHEREAS, the Philippine Medical Society of Northern California is a registered charitable organization based in the United States of America which has been conducting medical missions in the different parts of the country;

WHEREAS, the Provincial Government of Pangasinan, through the Bayambang District Hospital, in partnership with the Philippine Medical Society of Northern California and the Municipality of Bayambang, Pangasinan will join efforts in conducting a 5-day Surgical (Major and Minor Operations), Medical and Pediatric Mission on January 15-19, 2024;

WHEREAS, the Municipality of Bayambang, Pangasinan shall provide the People's Gymnasium and Public Plaza Auditorium as the venue for the minor medical activities and other necessary assistance for the medical mission;

WHEREAS, the Bayambang District Hospital shall provide its health care facilities and equipment and a suitable area for the loading and unloading of equipment and medical supplies of the said medical team for the duration of the aforesaid medical mission;

WHEREAS, the duties and responsibilities of the parties are stipulated in the Memorandum of Agreement which is made an integral part of this resolution;



NOW, THEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


