RESOLUTION NO. 100-2024

DECLARING MUNICIPAL ORDINANCE NO. 1-2023 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING AND MONITORING FISHERY ACTIVITIES IN THE MUNICIPAL WATERS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 1-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer has conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (a) (b) (2) (i), 149 (a) (b) (1) (2) & 447 (a) (1) (vi) of R.A. No. 7160; Section 2, Article XII (National Economy and Patrimony); Republic Act No. 9275, otherwise known as the "Philippine Clean Water Act of 2004; Department of Interior and Local Government Memorandum Circular No. 2018-59, entitled "Policies and Guidelines on the Regulation and Monitoring of Fishery Activities in Municipal Waters; and Republic Act No. 8550, known as the "The Philippine Fisheries Code of 1998";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
