### RESOLUTION NO. 102-2024

**APPROVING SB RESOLUTION NO. 193-2023 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “APPROVING THE 2<sup>ND</sup> SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Resolution No. 193-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Manaoag, Pangasinan prepared the municipality's 2<sup>nd</sup> Supplemental Investment Program for CY 2023. This was endorsed by the Council, through MDC Resolution No.06, Series of 2023 dated September 27, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program (SIP), which has a total investment requirement of ₱10,090,000.00, covers augmentation funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some municipal offices of the LGU, and implementation of priority programs and Disaster Risk Reduction projects of the municipality;

3. Funding for the SIP is embodied in the LGU's Supplemental Budget No. 2, CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02, Series of 2023 dated November 21, 2023;


