APPROVING RESOLUTION NO. 2023-265 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 4 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2023-265 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Mangaldan, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 4, CY 2023 of the LGU. This was endorsed by the Council, through MDC Resolution No. 8, Series of 2023 dated December 6, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental AIP No. 4, CY 2023, which has a total investment requirement of ₱11,865,939.00, covers augmentation of funds for Personal Services (granting of Performance – Based Bonus and other personnel benefits to qualified officials and employees) and Maintenance and Other Operating Expenses (granting of Gratuity Pay to Job Order and Contract of Service Workers) of the LGU; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 4 for CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-05 dated December 6, 2023;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;
