RESOLUTION NO. 105-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2023 OF MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P11,865,939.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Supplemental Budget No. 4 for CY 2023 involving total appropriations of P11,865,939.00, which was enacted on December 6, 2023 through Appropriation Ordinance No. 2023-05:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the grant for Performance Based Bonus (PBB) for FY 2022 shall be in accordance with the provisions of Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring Information and Reporting Systems Memorandum Circular No. 2022-1 dated March 24, 2022, and shall only be granted after receiving the individual Notice of Eligibility & submission of Form I to respective MLGOO;

- 2. That the reversion from Personal Services savings shall be in accordance with the provisions of Section 336 of R. A. No. 7160 (Use of Appropriated Funds & Savings);
- 3. That the appropriation for Other Personnel Benefits (SRI) shall be in accordance of Budget Circular No. 2023-2 dated December 13, 2023; and
- 4. That the grant of Gratuity Pay to Contract of Service & Job Order Workers in Government for FY 2023 of the municipality shall be in accordance with the provisions of Budget Circular No. 2023-3 dated December 14, 2023.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 4 for Calendar Year 2023 of Mangaldan, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Mangaldan, Pangasinan, for its information and guidance.
