APPROVING RESOLUTION NO. 367-11302023 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "APPROVING THE THIRD (3RD) SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2023 FUNDED BY UNAPPROPRIATED SURPLUS, SAVINGS AND REVERSION OF APPROPRIATIONS OF UNFILLED POSITIONS OF POZORRUBIO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 367-11302023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Pozorrubio, Pangasinan has identified items in their 3rd Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan on October 27, 2023 by the Municipal Development Council through Executive Committee MDC Resolution No. 4, Series 2023;
2. The SAIP covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, Capital Outlay of various municipal offices and implementation of development projects of the LGU, with the total investment requirement of Php20,393,256.16; and

3. Funding support for the full implementation of the same is embodied in their Supplemental Budget No. 3, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03-11302023 dated November 30, 2023, and approved by the Municipal Mayor on December 5, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Pozorrubio, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—


