DECLARING MUNICIPAL ORDINANCE NO. 05-10312023 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AN ORDINANCE UPDATING MUNICIPAL ORDINANCE NO. 01-021609 ENTITLED: AN ORDINANCE PROVIDING FOR INCENTIVES TO PUBLIC AND PRIVATE SCHOOL STUDENTS AND COACHES WHO WON IN VARIOUS DEPARTMENT OF EDUCATION SANCTIONED ACADEMICS AND SPORTS COMPETITIONS AND OTHER RELATED CONTESTS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Ordinance No. 05-10312023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iv) & 36 of R.A. No. 7160; Article II Section 17 of the 1987 Constitution; R.A. No. 10699, otherwise known as "An Act Expanding the Coverage of Incentives Granted to National Athletes and Coaches, Appropriating Funds Therefor, Repealing for the Purpose R.A. No. 9064, also known as the "National Athletes, Coaches and Trainers Benefits and Incentives Act of 2001"; and R. A. No. 8044, or the Youth in Nation-Building Act;
