RESOLUTION NO. 109-2024

DECLARING MUNICIPAL ORDINANCE NO. 06-10312023 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE POZORRUBIO MUNICIPAL SCHOLARSHIP PROGRAM (PMSP) IN THE MUNICIPALITY OF POZORRUBIO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Ordinance No. 06-10312023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (5) (xi) of R.A. 7160; R.A. No.109311, otherwise known as Universal Access to Quality Tertiary Education Act; R.A. No. 10648, An Act Providing Scholarship Grants to Top Graduates of All Public High Schools in State Universities and Colleges and Appropriating Funds Therefor; and Article II, Section 17 & Article XIV, Section 1 of the 1987 Philippine Constitution;


