**RESOLUTION NO. 11-2024**

**DECLARING ORDINANCE NO. 2023-26 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE INCIDENT COMMAND SYSTEM IN THE CITY OF ALAMINOS, PANGASINAN PROVIDING GUIDELINES IN ITS ACTIVATION AND PROPER USE AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its City Ordinance No. 2023-26 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted in accordance with Section 458 (a) (1) (iv) (vii) of R. A. No. 7160; Rule 7, Section 3 (h) of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as Philippine Disaster Risk Reduction and Management Act of 2010 and NDRRMC MC. No. 04, S-2012, dated March 28, 2012;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
