### RESOLUTION NO. 110-2024

**APPROVING RESOLUTION NO. 2023-255, S-2023 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 3<sup>rd</sup> SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CY 2023 OF THE MUNICIPALITY OF SISON, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2023-255, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sison, Pangasinan has identified items in their 3<sup>rd</sup> Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan for approval on November 28, 2023 by the Municipal Development Council - Executive Committee thru Resolution No. 04, Series of 2023;
2. The SAIP covers fund augmentation for Personal Services (granting of Service Recognition Incentive and Collective Negotiation Agreement Incentive to qualified LGU officials and employees and other Personnel Benefits), Maintenance and implementation of programs/projects of the LGU, with the total investment requirement of Php6,657,289.00;

3. Funding support for the full implementation of the same in the amount of Php6,657,289.00 is embodied in their proposed Supplemental Budget No. 2 for FY 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03, Series 2023 on December 11, 2023, and approved by the Municipal Mayor on December 19, 2023; and
4. The projects to be funded from the share of the LGU from the Tobacco Excise in the amount of Php1,722,289.00 are in consonance to the Local Budget Memorandum No. 89 “Collections of Excise Tax on Locally Manufactured Virginia – type cigarettes under Republic Act (RA) No. 7171, and Burley and Native Tobacco Excise Tax Pursuant to RA No. 8240” dated November 10, 2023.




