### RESOLUTION NO. 117-2024

**DECLARING MUNICIPAL ORDINANCE NO. 2023-024 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING THE MANUFACTURE AND USE OF “BOGA” AND OTHER IMPROVISED PYROTECHNIC DEVICES AND PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2023-024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer has conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 447 (a) (i) (ii) (iii) of R.A. No. 7160 and Sections 1 and 4 of R.A. No. 7183, otherwise known as “An Act Regulating the Sale, Manufacture, Distribution and Use of Firecrackers and Other Pyrotechnic Devices”;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;


