## **RESOLUTION NO. 118-2024**

DECLARING MUNICIPAL ORDINANCE NO. 2023-026 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF QUEZON BOULEVARD INFRONT OF THE MUNICIPAL COMPLEX AND HALF LANE OF RIZAL STREET INFRONT OF MUNICIPAL PLAZA FROM CORNER MAGSAYSAY STREET TO CORNER BONIFACIO STREET TO COMMENCE ON DECEMBER 1 TO DECEMBER 31 AND FROM FEBRUARY 20 UNTIL MARCH 27 OF EVERY YEAR DURING THE CHRISTMAS AND TOWN FIESTA CELEBRATIONS IN TAYUG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2023-026 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer has conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 21 (a) (c) (d) of R.A. No. 7160 and Article 43 of its Implementing Rules and Regulations (IRR)";

WHEREAS, the Municipality shall provide alternate routes during the said temporary closure and signages must be placed at strategic places, roads or alleys in order to notify the public;

> **RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2023-026 of the Sangguniang Bayan of Tayug, Pangasinan entitled, "An Ordinance authorizing the temporary closure of a portion of Quezon Boulevard infront of the Municipal Complex and half lane of Rizal Street infront of Municipal Plaza from corner Magsaysay Street to corner Bonifacio Street to commence on December 1 to December 31 and from February 20 until March 27 of every year during the Christmas and town fiesta celebrations in Tayug, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
