RESOLUTION NO. 12-2024

DECLARING ORDINANCE NO. 2023-31 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE DECLARING THE MONTH OF OCTOBER OF EVERY YEAR AS “COOPERATIVE MONTH” IN THE CITY OF ALAMINOS, PANGASINAN, IN CONSONANCE WITH REPUBLIC ACT NO. 11502 AND PROVIDING FUNDS THEREFOR” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its City Ordinance No. 2023-31 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said city ordinance and found out that the same was enacted in accordance with Sections 16, 33, 35 & 458 (a) (1) and (6) of R. A. No. 7160; and Republic Act No. 11502, otherwise known as “An Act Declaring the Month of October of Every Year as the National Cooperative Month”;

WHEREAS, however, the LGU shall explicitly identify the specific allocation for the implementation of the subject Ordinance so as not to affect allocation already appropriated to specific expenditures of the LGU;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—




