**RESOLUTION NO. 124-2024**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2023 OF BOLINAO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P6,675,350.58, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2023 involving total appropriations of P6,675,350.58, which was enacted on December 7, 2023 through Appropriation Ordinance No. 2023-03;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
2. That the grant of Gratuity Pay to Contract of Service & Job Order Workers in Government for FY 2023 of the municipality shall be in accordance with the provisions of Budget Circular No. 2023-3 dated December 14, 2023; and

3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Annual Investment Program of the municipality and supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—
