RESOLUTION NO. 125-2024

APPROVING RESOLUTION NO. 110, S-2023 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03, CY-2023 OF THE LOCAL GOVERNMENT UNIT, DASOL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its SB Resolution No. 110, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Dasol, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 3 CY 2023. This was endorsed to the Sangguniang Bayan on December 5, 2023 through MDC ExeCom Resolution No. 4, Series of 2023;
2. Said SAIP covers fund augmentation for the Maintenance and Other Operating Expenses of various municipal government offices, and the implementation of disaster risk reduction management program of the local government unit; and

- Funding support for the proposed SAIP, with a total investment requirement of Php3,349,699.41, is embodied in the municipality's Supplemental Budget No.3 CY 2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 183 on December 12, 2023 and approved by the Municipal Mayor on December 20, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Dasol, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—
