RESOLUTION NO. 127-2024

DECLARING MUNICIPAL ORDINANCE NO. 07-2023 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING VOLUNTARY BLOOD DONATION PROGRAM IN THE MUNICIPALITY OF DASOL, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Ordinance No. 07-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Republic Act No. 7719, otherwise known as “The National Blood Services Act of 1994”; and Sections 16, 17 (b) (2) (iii), 447 (a) (2) (i) of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 07-2023 of the Sangguniang Bayan of Dasol, Pangasinan, entitled “An Ordinance establishing Voluntary Blood Donation Program in the Municipality of Dasol, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
