APPROVING MUNICIPAL RESOLUTION NO. 210-2023 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 03, SERIES OF 2023 OF THE MUNICIPALITY OF ANDA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Resolution No. 210-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Anda, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 03, Series of 2023. This was endorsed to the Sangguniang Bayan for approval on October 16, 2023 by the Municipal Development Council through MDC Resolution No. 04, Series of 2023;
- 2. Said SIP covers fund augmentation for Maintenance and Other Operating Expenses of some offices of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP800,000.00 is embodied in their proposed Supplemental Budget No. 02 for Budget Year 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02, Series of 2023 on November 6, 2023 and approved by the Municipal Mayor on November 14, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Anda, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—
