APPROVING RESOLUTION NO. 470, S-2023 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) EXECOM THRU RESOLUTION NO. 005, SERIES OF 2023 AMOUNTING TO NINE MILLION THIRTY-NINE THOUSAND PESOS (P9,039,000.00)"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its SB Resolution No. 470, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Municipal Development Council of Bayambang, Pangasinan prepared the Supplemental Annual Investment Program No. 2 for CY 2023. This was endorsed by the Council, through MDC ExeCom Resolution No. 005, Series of 2023 dated November 6, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. The Supplemental AIP, which has a total investment requirement of P9,039,000.00, covers the augmentation of funds for Capital Outlay (purchase of two units garbage trucks, one unit vehicle and IT equipment for various offices) of the LGU; and

> Funding support for the LGU's Supplemental AIP is embodied in their Supplemental Budget No. 02, CY 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04, Series of 2023 dated November 23, 2023.
