#### **RESOLUTION NO. 138-2024**

APPROVING RESOLUTION NO. 131, S-2023 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) OF THE MUNICIPALITY OF CALASIAO, FOR THE YEAR 2023"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its SB Resolution No. 131, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Municipal Development Council of Calasiao, Pangasinan prepared the municipality's Supplemental Annual Investment Program for CY 2023. This was endorsed by the Council, through MDC ExeCom Resolution No. 9, Series of 2023 dated November 23, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental Annual Investment Program, which has a total investment requirement of P 10,711,005.17, covers the augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) of some municipal offices, and implementation of LDRRM projects and GAD activities of the LGU; and

3. Funding for the Supplemental AIP in the amount of ₱10,611,005.17 is embodied in the LGU's Supplemental Budget No. 4, FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 12, Series of 2023 dated November 28, 2023. (The remaining amount of P100,000.00 will be derived from the National Government/Department of the Interior and Local Government.)

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—
