**RESOLUTION NO. 140-2024**

**APPROVING RESOLUTION NO. 134, S-2023 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) OF THE MUNICIPALITY OF CALASIAO, FOR THE YEAR 2023”**

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its SB Resolution No. 134, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Calasiao, Pangasinan prepared the municipality’s Supplemental Annual Investment Program for CY 2023. This was endorsed by the Council, through MDC ExeCom Resolution No. 10, Series of 2023 dated December 13, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of P 6,083,842.28, covers the augmentation of funds for Personal Services (granting of Service Recognition Incentives to qualified municipal officials and employees), Maintenance and Other Operating Expenses (granting of Gratuity Pay for Contract of Service and Job Order Workers), and Capital Outlay of some municipal offices, and implementation of Disaster Risk Reduction projects and GAD activities/projects of the LGU; and

4. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 5, FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 13, Series of 2023 dated December 18, 2023.
