APPROVING RESOLUTION NO. 306, S-2023 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 3 WITH THE CY 2023 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 2 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its SB Resolution No. 306, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Asingan, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No. 2 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on November 22, 2023 by the Municipal Development Council through Resolution No. 3, S-2023;
- 2. The Supplemental Annual Investment Plan No. 2 with an investment requirement amounting to Php4,921,502.11 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and implementation of disaster programs of LGU Asingan; and

3. The Sangguniang Bayan enacted Supplemental Budget No. 2 for Calendar Year 2023 through Appropriation Ordinance No.3, Series of 2023 dated November 29, 2023 to support the implementation of the Supplemental Annual Investment Plan No.2 of the municipality.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Asingan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—
