APPROVING RESOLUTION NO. 23-81 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2023-003 EMBODYING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 2 FOR FY 2023 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its SB Resolution No. 23-81 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sta. Maria, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 02 for FY 2023. This was endorsed to the Sangguniang Bayan on October 25, 2023 through MDC Executive Committee Resolution No. 2023-003;
- The SAIP No. 02 of the municipality covers fund augmentation for Personal Services (granting of Performance Based Bonus (PBB) to qualified officials and employees) and Maintenance and Other Operating Expenses of LGU Sta Maria;

3. Funding support for the proposed SAIP, with a total investment requirement of PhP12,124,291.60 is embodied in the municipality's Supplemental Budget No. 2, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 23-02 on December 12, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Maria, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was–

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 23-81 of the Sangguniang Bayan of Sta. Maria, Pangasinan, entitled "Approving the Municipal Development Council (MDC) Resolution No. 2023-003 embodying the Supplemental Annual Investment Program (SAIP) No. 2 for FY 2023 of the Municipality of Sta. Maria, Pangasinan";
