PROVINCIAL RESOLUTION NO. 159-2024

RATIFYING THE UPDATED LISTS OF RECIPIENTS FOR TWO (2) PROJECTS SPECIFICALLY FOR THE RECIRCULATING DRYERS AND HAND TRACTORS AS PROVIDED UNDER THE TERMS AND CONDITIONS OF THE ASSISTANCE FOR ECONOMIC AND SOCIAL DEVELOPMENT (ASENSO) FOR LOCAL GOVERNMENT UNITS FINANCING PROGRAM OF THE PROVINCE OF PANGASINAN WITH THE DEVELOPMENT BANK OF THE PHILIPPINES

WHEREAS, Provincial Resolution No. 686-2021, approved by the Sangguniang Panlalawigan on August 16, 2021, authorized then Provincial Governor, Amado I. Espino III, to negotiate and enter into a loan agreement with the Development Bank of the Philippines in the amount of Four Hundred Million Pesos (P400 Million) under the terms and conditions of the assistance for Economic and Social Development (ASENSO) for Local Government Units Financing Program;

WHEREAS, loan proceeds approved under the program will be utilized to finance different projects including 2 units of recirculating dryer amounting to P5,998,500.00 and 83 units of hand tractor with trailer and implements amounting to P14,998,100.00 Million and the list of recipients has already been identified for the said purpose;

WHEREAS, after a thorough evaluation of the submitted lists of beneficiaries under the program, it was found out that the project of two recirculating dryers to the Municipality of Bugallon is not viable because of unavailability of a suitable location for the construction of a warehouse to house the dryer, hence the change of beneficiary to the Municipality of Sta. Barbara which has a newly constructed warehouse that may serve the purpose;

WHEREAS, on the other hand, the updated list of recipients for the hand tractor project is in keeping with the thrust of the national government to improve food security and to ensure equitable distribution to the cities and municipalities of the Province;


RESOLVED, FURTHER, that the corresponding amendments to Provincial Resolution No. 686-2021 be made to incorporate the changes made in line with this Resolution;
