APPROVING RESOLUTION NO. 2023-224 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS CITY, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2023 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 05 OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO TWENTY-FOUR MILLION SIX HUNDRED NINETY-EIGHT THOUSAND ONE HUNDRED FIVE PESOS AND EIGHTY CENTAVOS (P24,698,105.80)”

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2023-224 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alaminos City, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 05, Series of 2023. This was endorsed to the Sangguniang Panlungsod for approval on November 23, 2023 by the City Development Council Executive Committee thru Resolution No. 2023-08 Series of 2023;

2. Said SAIP covers fund augmentation for Personal Services (granting of Service Recognition Incentives to qualified government employees), Maintenance and Other Operating Expenses and PPE/Capital Outlay of some offices of the LGU, and the implementation of disaster risk reduction and management programs of the LGU; and
3. Funding support for the implementation of the same in the amount of Php24,698,105.80 is embodied in their proposed Supplemental Budget No. 05 for Fiscal Year 2023 which was enacted by their Sangguniang Panlungsod thru Appropriation Ordinance No.2023-06 on November 28, 2023 and approved by the City Mayor on December 05, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Alaminos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2023-224 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled “Confirming/Approving in toto the proposed CY 2023 Supplemental Annual Investment Program No. 05 of the City of Alaminos, Pangasinan amounting to Twenty-Four Million Six Hundred Ninety-Eight Thousand One Hundred Five Pesos and Eighty Centavos (P24,698,105.80)”;
