**DECLARING ORDINANCE NO. 2023-28 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE FOLLOWING THREE (3) POSITIONS UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIAN AND ONE (1) POSITION UNDER THE CITY HEALTH OFFICE OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN, TO WIT: 1. SUPERVISING ADMINISTRATIVE OFFICER (LOCAL LEGISLATIVE STAFF OFFICER V); 2. ADMINISTRATIVE OFFICER V; 3. COMPUTER PROGRAMMER III; AND 4. MEDICAL TECHNOLOGIST IV” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-28 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;


