**RESOLUTION NO. 167-2024**

**DECLARING ORDINANCE NO. 2023-30 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING SMALL REMOTELY PILOTED AIRCRAFT SYSTEM OR UNMANNED AERIAL VEHICLES, COMMONLY KNOWN AS DRONES, TO OPERATE WITHIN ONE HUNDRED (100) METER RADIUS FROM JAIL FACILITIES WITHIN THE JURISDICTION OF THE CITY OF ALAMINOS, PANGASINAN, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-30 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 458 (a) (1) (iii) of R. A. No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
