DECLARING ORDINANCE NO. 2023-38 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE ABOLISHING THE POSITION TITLE OF ENVIRONMENTAL MANAGEMENT SPECIALIST I UNDER THE OFFICE OF THE CITY GENERAL SERVICE OFFICE AND CREATING THE POSITION TITLE OF SUPERVISING ENVIRONMENTAL MANAGEMENT SPECIALIST (SG 22/1) UNDER THE CITY ENVIRONMENTAL AND NATURAL RESOURCES OFFICE (CENRO) OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT
