APPROVING RESOLUTION NO. 2023-170 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 4, CY 2023 OF SUAL, PANGASINAN AMOUNTING TO ONE MILLION FIVE HUNDRED SIXTY-FOUR THOUSAND TWO HUNDRED THIRTY-ONE & 19/100 PESOS (P1,564,231.19)”

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2023-170 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan has identified items in their Supplemental Investment Program (SIP) No.4 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on September 7, 2023 by the Municipal Development Council through Resolution No. 6, Series of 2023;
2. The SIP No. 4 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some offices of the LGU; and

- Funding support for the implementation of the same in the amount of PhP1,564,231.19 is embodied in their proposed Supplemental Budget No. 04 CY 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 05, CY 2023 on September 18, 2023 and approved by the Municipal Mayor on October 06, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;
