APPROVING RESOLUTION NO. 12-23-198 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "ADOPTING AND APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM 2 (SIP 2) CY-2023 OF THE LGU MABINI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Resolution No. 12-23-198 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Mabini, Pangasinan has identified items in their Supplemental Investment Program 2 for CY 2023. This was endorsed to the Sangguniang Bayan on December 15, 2023 through MDC (ExeCom) Resolution No. 03 Series of 2023;
- 2. The SIP No. 2 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive and Collective Negotiation Agreement incentive to qualified government employees) and Maintenance and Other Operating Expenses of some municipal government offices of the LGU.; and

3. Funding support for the proposed SIP, with a total investment requirement of PhP8,677,593.26 is embodied in the municipality's Supplemental Budget No.2 FY2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 3, Series 2023 on December 18, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mabini, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 12-23-198 of the Sangguniang Bayan of Mabini, Pangasinan, entitled "Adopting and Approving the Supplemental Investment Program 2 (SIP 2) CY-2023 of the LGU Mabini, Pangasinan";
