DECLARING ORDINANCE NO. 14-2023 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING PLANTILLA POSITION OF LOCAL LEGISLATIVE STAFF EMPLOYEE II, SALARY GRADE 4 UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG BAYAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
