## **RESOLUTION NO. 175-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 11-2023 OF THE** SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING **REGISTRATION OF** FISHING VESSELS WITH THREE (3) GROSS TONNAGE AND BELOW, UTILIZING THE MUNICIPAL WATERS OF SUAL, PANGASINAN AND PROVIDING GUIDELINES FOR ITS REGISTRATION WITH THE LOCAL GOVERNMENT OF SUAL, PANGASINAN AND PENALTIES THEREOF" AS PROVIDING WITHIN THE **CONFERRED POWERS OF THE SANGGUNIAN TO ENACT** 

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Municipal Ordinance No. 11-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 132, 149 (b) (3) & 447 (a) (3) (i) of R. A. No. 7160; Republic Act No. 10601, otherwise known as "Agricultural and Fisheries Mechanization Law"; and Department of Agriculture and Department of the Interior and Local Government Joint Memorandum Circular No. 2018-02;

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of R. A. No. 7160;
