RESOLUTION NO. 176-2024

DECLARING ORDINANCE NO. 15-2023 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “AN ORDINANCE RECLASSIFYING/DOWNGRADING THE PLANTILLA POSITION OF LOCAL DISASTER RISK REDUCTION MANAGEMENT OFFICER III (LDRRMO III), SALARY GRADE 18 TO LOCAL DISASTER RISK REDUCTION MANAGEMENT OFFICER II (LDRRMO II), SALARY GRADE 15 UNDER THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT


