**RESOLUTION NO. 181-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 45, S-2023 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 1, SERIES OF 2016 ON THE OFFICIAL ANNUAL DATE OF CELEBRATION OF ANSAKKET FESTIVAL FROM OCTOBER 30 TO MARCH 16” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 45, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (6) of R. A. No. 7160;

**WHEREAS**, the Sangguniang Bayan shall be reminded that it is not empowered to declare the dates specified in the subject ordinance as holidays or non-working days, as the same will necessary affect labor practices, particularly in the rates of pay of the workers/laborers;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


