**RESOLUTION NO. 182-2024**

**APPROVING RESOLUTION NO. 54, S-2023 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BUGALLON, PANGASINAN FOR CALENDAR YEAR 2023”**

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 54, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Bugallon, Pangasinan prepared the municipality’s Revised Annual Investment Program for CY 2023. This was endorsed by the Council, through MDC Resolution No. 03, Series of 2023 dated December 05, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991; and
2. The LGU revised their AIP for CY 2023 to include a new project, which is the Purchase of one (1) Mobile Medical Clinic, proposed to be funded from their Seal of Good Local Governance Incentive Fund (SGLGIF) amounting to P5,000,000.00.


