APPROVING RESOLUTION NO. 57, S-2023 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR FY 2023 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN INVOLVING THE AMOUNT OF FOURTEEN MILLION ONE HUNDRED FORTY ONE THOUSAND PESOS (P14,141,000.00)”

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 57, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Bugallon, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for FY 2023. This was endorsed by the Council, through MDC Resolution No. 04, Series of 2023 dated December 18, 2023, to the Sangguniang Bayan for approval;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱14,141,000.00, covers the augmentation of funds for Personal Services (granting of Collective Negotiation Agreement Incentive and Service Recognition Incentive to qualified municipal employees), and Maintenance and Other Operating Expenses of the LGU; and

3. Funding support for the SIP is embodied in the LGU's Supplemental Budget No. 2 for FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-01 dated December 21, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bugallon, Pangasinan;
