RESOLUTION NO. 19-2024

DECLARING ORDINANCE NO. 09-2023 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) OF SUAL, PANGASINAN, ENUMERATING ITS OBJECTIVES, FUNCTIONS AND SERVICES AND APPROPRIATING FUNDS THEREOF” WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 09-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 76, 443 (c) (2) & 447 (a) (1) (viii) of R. A. No. 7160; and Section 3 of Republic Act No. 8759, otherwise known as the “Public Employment Service Office Act of 1999 and Republic Act No. 10691, or the “Expanded PESO Law”;

WHEREAS, a separate Ordinance should be submitted to include the qualifications, duties and functions of the proposed plantilla positions of the Public Employment Service Office of the municipality;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (a) of R. A. No. 7160;


