RESOLUTION NO. 191-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 01 FOR CALENDAR YEAR 2023 OF SAN JACINTO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P34,492,121.25, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Supplemental Budget No. 01, for Calendar Year 2023 involving total appropriations of P34,492,121.25, which was enacted on October 27, 2023 through Appropriation Ordinance No. 2023-01;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the reversion of appropriation shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

- 3. That the projects funded from Tobacco Excise Tax FY 2020 Collections shall be in accordance with the Local Budget Memorandum No. 86 dated December 14, 2022;
- 4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and
- That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Annual Investment Program of the municipality and its supplement thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in Its Entirety the Supplemental Budget No. 01, for Calendar Year 2023 of San Jacinto, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of San Jacinto, Pangasinan, for its information and guidance.
