APPROVING RESOLUTION S-2023 **OF** PANGASINAN, BAYAN **OF** BAUTISTA, SANGGUNIANG ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 4, S-2023 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 2 CY 2023 AMOUNTING TO EIGHT MILLION FIVE HUNDRED SIXTY SEVEN THOUSAND FIVE HUNDRED SIXTY FIVE PESOS AND 75/100 (P8,567,565.75)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 388, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

 Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Bautista, Pangasinan has identified items in their Supplemental Annual Investment Program This was endorsed to the Sangguniang Bayan for approval on November 17, 2023 by the Municipal Development Council thru Executive Committee MDC Resolution No. 4, S. of 2023;

- 2. Said SAIP covers fund augmentation for Personal Services (granting of Service Recognition Incentive to Municipal employees), Maintenance and Other Operating Expenses and Capital Outlay of various municipal offices, and implementation of development projects of the LGU.; and
- 3. Funding support for the full implementation of the same in the amount of Php 8,567,565.75 is embodied in their Supplemental Budget No. 2 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2 S. of 2023 dated December 4, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bautista, Pangasinan;

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 388, S-2023 of the Sangguniang Bayan of Bautista, Pangasinan, entitled "Approving the Supplemental Investment Program of the Municipality of Bautista, Province of Pangasinan under MDC Resolution No. 4, S-2023 to be funded from the Supplemental Budget No. 2 CY 2023 amounting to Eight Million Five Hundred Sixty Seven Thousand Five Hundred Sixty Five Pesos and 75/100 (P8,567,565.75";
