PROVINCIAL RESOLUTION NO. 198-2024

AUTHORIZING THE LAND BANK OF THE PHILIPPINES-LINGAYEN BRANCH TO REACTIVATE DORMANT ACCOUNTS OF THE PROVINCIAL GOVERNMENT OF PANGASINAN AND FURTHER AUTHORIZING THE PROVINCIAL GOVERNOR AND THE PROVINCIAL TREASURER TO EXECUTE AND SIGN ALL PERTINENT DOCUMENTS THEREOF

WHEREAS, LANDBANK records show that there are deposit accounts under the name of the Provincial Government of Pangasinan which have been classified as "Dormant" status;

WHEREAS, the Provincial Government of Pangasinan still needs to maintain the said accounts for its financial transactions;

WHEREAS, it is necessary therefore to reactivate eight (8) account numbers under the following account names of the Province:
