### RESOLUTION NO. 199-2024

**APPROVING MUNICIPAL RESOLUTION NO. 231-2023 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 04 SERIES OF 2023 OF THE MUNICIPALITY OF ANDA, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 231-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Anda, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 04, Series of 2023. This was endorsed to the Sangguniang Bayan for approval on December 12, 2023 by the Municipal Development Council through MDC Resolution No. 05, Series of 2023;
2. Said SIP covers fund augmentation for Personal Services (Granting of Collective Negotiation Agreement Incentive and Performance-Based Bonus to Qualified Employees) and Maintenance and Other Operating Expenses of some offices of the LGU; and

3. Funding support for the implementation of the same in the amount of Php3,741,670.11 is embodied in their proposed Supplemental Budget No. 03 for Budget Year 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03, Series of 2023 on December 18, 2023.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Anda, Pangasinan;


