**RESOLUTION NO. 208-2024**

**APPROVING RESOLUTION NO. 077-2023 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF LABRADOR, PANGASINAN FOR CY 2024”**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 077-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject Resolution is in consonance to Section 106, 109, and 114 of the Local Government Code of 1991. The Municipal Development Council of Labrador, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2024. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 003-S-2023 dated August 18, 2023;
2. The Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007, DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Labrador is categorized into general public, social, economic, and other services sectors, and covers (a) all the regular budgetary requirements for the

operations of the different offices broken down into Personal Services (PS), Maintenance and Other Operating Expenses (MOOE), and Capital Outlay; (b) priority development programs/projects of the LGU, including those funded by the 20% Development Fund, (c) Disaster Risk Reduction (DRR) programs, projects, and (d) activities in pursuance of the objectives of Gender and Development (GAD) of the LGU as indicated in the DILG-endorsed GAD Plan and Budget. Also attached to the AIP are (a) Local Climate Change Action Plan, (b) Peace and Order Plan, (c) Local Nutrition Action Plan, (d) Municipal Tourism Culture Heritage Promotion and Conservation Plan, (e) List of Programs/Projects/Activities for the Local Council for Protection of Children, (f) List of PPAs for Senior Citizens and Persons with Disability of the LGU, (g) List of PPAs to Combat Acquired Immune Deficiency Syndrome (AIDS) and (h) Annual Project Procurement and Management Plan. It is recommended however, that the LGU shall use the new prescribed AIP Summary Form in accordance to Local Budget Memorandum No. 87 dated June 9, 2023. The LGU shall use the new prescribed AIP Summary Form in their succeeding AIPs and Supplemental AIPs;

3. The proposed AIP of Labrador has a total investment requirement of Php147,923,568.00 which will be financed by the LGU as embodied in their proposed Annual Budget for CY 2024 enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03-2023 dated October 23, 2023;
4. This AIP is in accordance with Section 287 of LGC of 1991. Twenty percent (20%) of the LGU's IRA/NTA (P133,923,268.00) amounting to P26,784,653.60, is allocated for development projects. The development projects proposed to be funded by the 20% Development Fund were based on the Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
5. The programs/projects/activities (PPAs) proposed to be funded by the 5% Local Disaster Risk Reduction and Management Investment Fund, amounting to P7,396,178.40, is in accordance with RA 10121. The programs/projects/activities proposed to be funded from the 70% of the 5% LDRRMF (P5,177,324.88) are based on the Joint Memorandum Circular No. 2013-1 of the NRDRMC-DBM and DILG dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). It is, however, recommended that the LDRRM Plan of the LGU be forwarded to the Office of Civil Defense-Regional Office I for their review/evaluation as per provisions of DBM Local Budget Memorandum No. 77 dated May 15, 2018 particularly Item 2.2.12 (...Annual Investment Program, supported by OCD-reviewed LDRRM Plan, etc.) and DBM Local Budget Memorandum No. 85 dated June 15,

2022, particularly Item 2.2.17 (...AIP, supported by LDRRM Plan as reviewed by the appropriate reviewing authority...);

6. The LGU of Labrador had also identify programs, projects and activities which are responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
7. The Gender and Development Plan and Budget for CY 2024 of the LGU was reviewed and approved by the Department of the Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and content with the provisions of the PCW-DILG-DBM-NEDA Joint Memorandum Circular (JMC) Nos. 2013-01 and 2016-01 (Guidelines on the Localization of the Magna Carta of Women).




