**APPROVING RESOLUTION NO. 180, S-2023 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED “REVISING THE 2023 ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mapandan, Pangasinan submitted its SB Resolution No. 180, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Mapandan, Pangasinan prepared the Municipality’s Revised Annual Investment Program for CY 2023. This was indorsed by the Council through MDC Resolution No. 17, S-2023 dated November 6, 2023. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991; and
2. The LGU revised their AIP for CY 2023 to include new projects proposed to be funded from their Unexpected Balance of LDRRM Fund (CY 2019-022) amounting to P3,514,635.85, which emanated from the MDRRM Council through MDRRMC Resolution No. 7, Series of 2023 dated October 24, 2023. This is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote: “The unexpected balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the

Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP”.
