#### APPROVING RESOLUTION NO. 181, S-2023 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "ADOPTING THE COMPREHENSIVE LAND USE PLAN IN THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN FOR THE TERM 2022-2032"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 181, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer and the Provincial Land Use Committee have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (2) (viii) of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Comprehensive Land Use Plan (CLUP) of Mapandan, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to Section 2 (b) of Executive Order No. 72, S-1993;

WHEREAS, the PLUC certified that the Municipality had incorporated in the final draft its recommendations and suggestions;

WHEREAS, the CLUP of Mapandan, Pangasinan is found to be in conformity with the existing Land Use Planning Guidelines, Laws and Regulations and other development plans of the Province;
