APPROVING RESOLUTION NO. 2023-265 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2023-07 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2023, REQUIRING A TOTAL FUNDING OF TWO MILLION FOUR HUNDRED FIFTEEN THOUSAND PESOS (P2,415,000.00)"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 2023-265 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 2023-07, CY 2023. This was endorsed by the Council, through MDC Resolution No. 2023-17, Series of 2023 dated December 15, 2023. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 3. Said Supplemental AIP, which has a total investment requirement of
 ₱2,415,000.00, covers fund augmentation for Maintenance and Other
 Operating Expenses (granting of Gratuity Pay for Contract of Service and
 Job Order Workers) of the LGU; and

4. Funding for the full implementation of this Supplemental AIP is embodied in their Supplemental Budget No.2023-06, FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-033, dated December 28, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
