#### **RESOLUTION NO. 218-2024**

#### DECLARING THE SUPPLEMENTAL BUDGET NO. 2023-06 FOR CALENDAR YEAR 2023 OF STA. BARBARA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,415,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Supplemental Budget No. 2023-06 for CY 2023 involving total appropriations of P2,415,000.00, which was enacted on December 28, 2023 through Appropriation Ordinance No. 2023-033, S-2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the grant of Gratuity Pay to Contract of Service & Job Order Workers in Government for FY 2023 of the municipality shall be in accordance with the provisions of Budget Circular No. 2023-3 dated December 14, 2023; and
- 2. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Fund and Savings).
